## CHILD CRISIS ARIZONA Expands its Early Head Start Program

Mesa Location Will Serve More than **100** Children

Child Crisis Arizona is pleased to announce that through federal funding received by the Office of Head Start, it is able to expand its Early Head Start services to Mesa.

Construction and renovations for the program, which will include six classrooms and provide center-based service to 48 children and home-based service to 64 children and pregnant women, will begin in September.

Thank you to The Bob and Renee Parsons Foundation who allowed for the rebranding and merger efforts which led to the announcement of the new name, logo and brand of the agency. The agency also launched a new presence on social media and a website, and have grown a loyal following. The Parson's funding also let us integrate our two IT systems and bring employee benefits to alignment between the two agencies.

- Because of the community's need, Child Crisis Arizona has **expanded** capacity at the Phoenix Shelter to 36 beds. We are now able to serve a total of 78 children birth to 8 years old between the two shelters.



- Parenting classes and workshops have **expanded** offerings at both Mesa and Phoenix locations and our supporters have helped us launch partnerships with a handful of local community nonprofits such as Goodwill (see Goodwill article on page 2).
- The counseling program expanded its hours and days, and our therapists have become certified as youth trauma specialists.

We are proud of our accomplishments and are convinced that with the combined efforts of our donors, volunteers, staff and the community, we will continue to expand the offerings of Child Crisis Arizona. **Thank you!**

"Volunteering with Child Crisis Arizona was the most enriching experience I ever had," says Debbie Tyndall who served as a volunteer in the 90s. Debbie's volunteering experience fulfilled her personal mission to find meaningful work, but it also led to a lifetime friendship with a child from the Mesa Emergency Shelter.

During one of her shifts, Debbie met Johnny who was placed due to neglect and his parents' drug use. Quickly, Debbie and Johnny developed a special bond, which led Debbie to become certified to take Johnny on offsite field trips to places such as the zoo, park and movies. Debbie knew in her heart that Johnny's forever family was out there for him.

Johnny's forever family did come forward and Johnny had his forever home. Johnny's adoptive mom remained in contact with Debbie, and for more than 20 years now Debbie has remained a mentor in Johnny's life. She was there for his high school graduation and his wedding. Today, Johnny is happily married living in China teaching English.

Debbie cherished her time so much as a volunteer that her and husband, Charles, created a trust and made Child Crisis Arizona the beneficiary. Debbie and Charles know firsthand their gift will impact the lives of the children we serve. They hope it will create other happy stories for children needing foster/adoptive homes and have the chance to have other volunteers make a lasting impact on their lives.
