EMERGENCY CHILDREN'S SHELTERS: CHILD CRISIS ARIZONA SHELTERS ARE LOCATED IN PHOENIX AND MESA, AND ARE THE ONLY EMERGENCY SHELTERS IN MARICOPA COUNTY FOR CHILDREN BIRTH TO 11 OFFERING SERVICES FOR UP TO 69 CHILDREN. CHILDREN ARE ADMITTED DUE TO NEGLECT, ABANDONMENT, ABUSE OR PARENTAL INCARCERATION. CHILDREN ARE PLACED BY THE DEPARTMENT OF CHILD SAFETY, TRIBAL GOVERNMENTS, OR BY FAMILIES IN NEED. SPECIALLY TRAINED STAFF AND VOLUNTEERS PROVIDE CARE AND SUPPORT. THE SHELTERS ARE ABLE TO ADDRESS MEDICAL NEEDS, COUNSELING AND THERAPY. THE SHELTERS ARE HOME-LIKE FACILITIES PROVIDING, 1) SUPERVISED CARE - 24 HOURS A DAY, SEVEN DAYS A WEEK, 2) BALANCED MEALS AND NUTRITIOUS SNACKS, 3) CLOTHING AND PERSONAL-CARE ITEMS, (CONTINUED ON SCHEDULE)

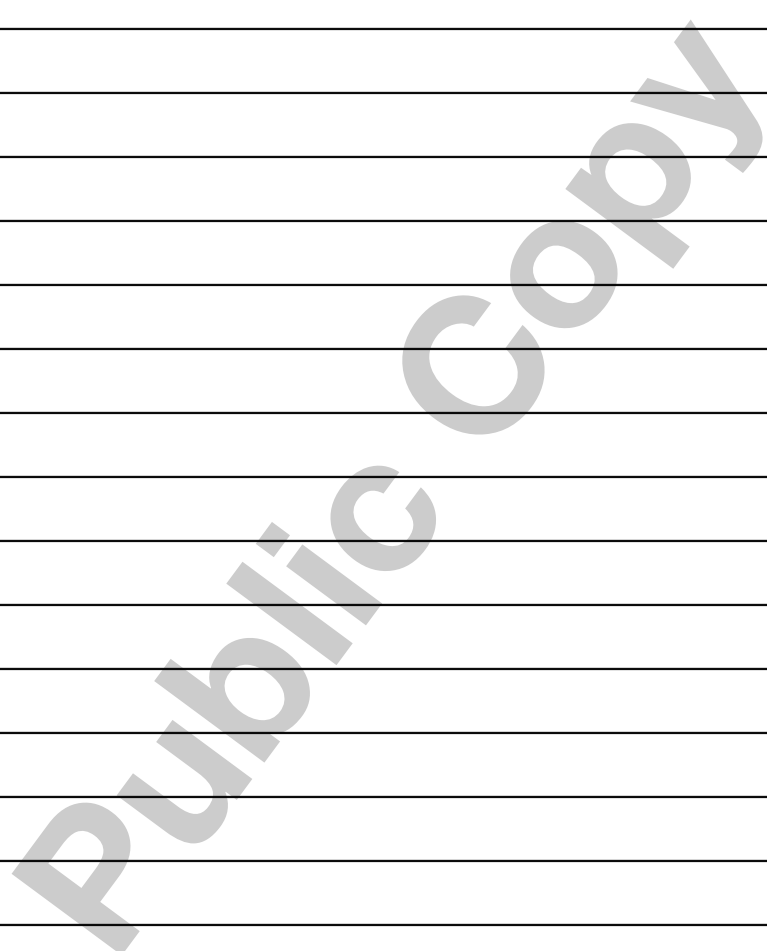

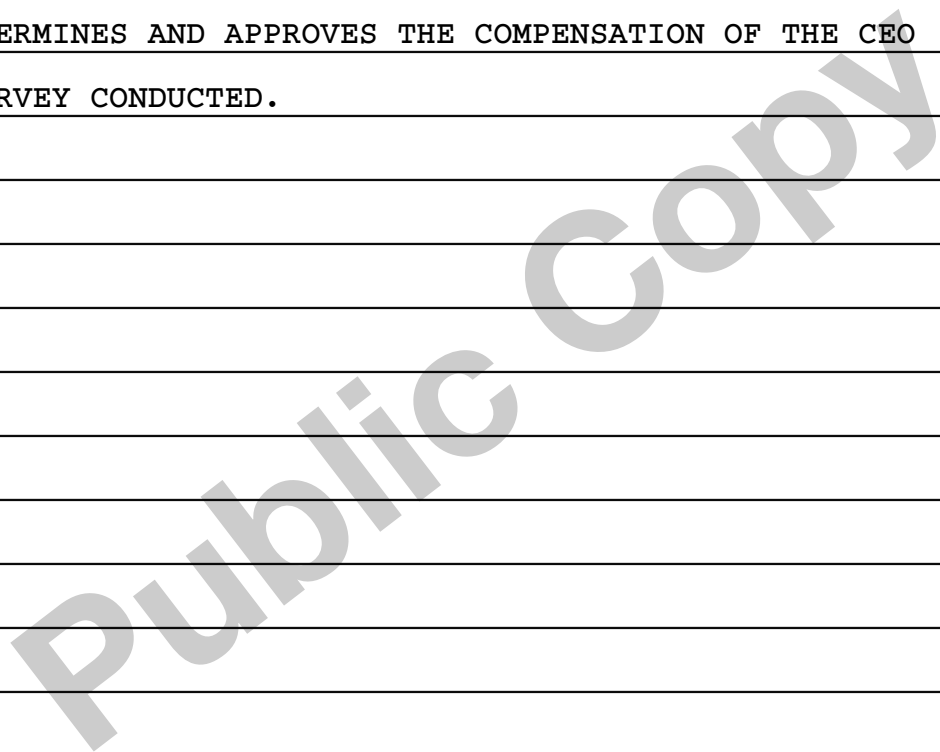

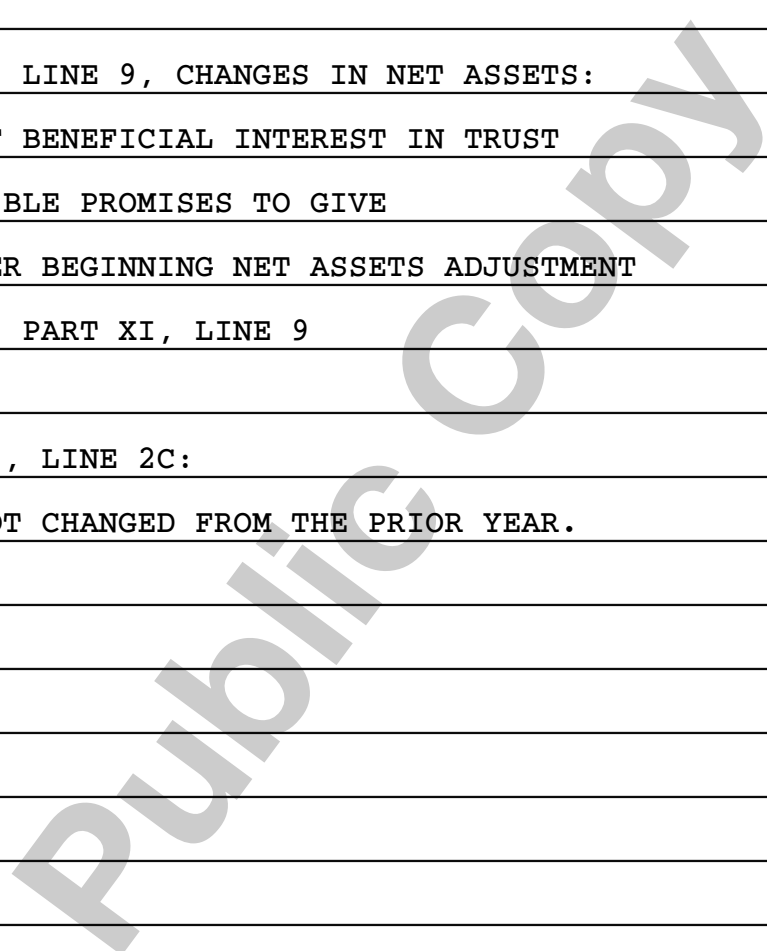
