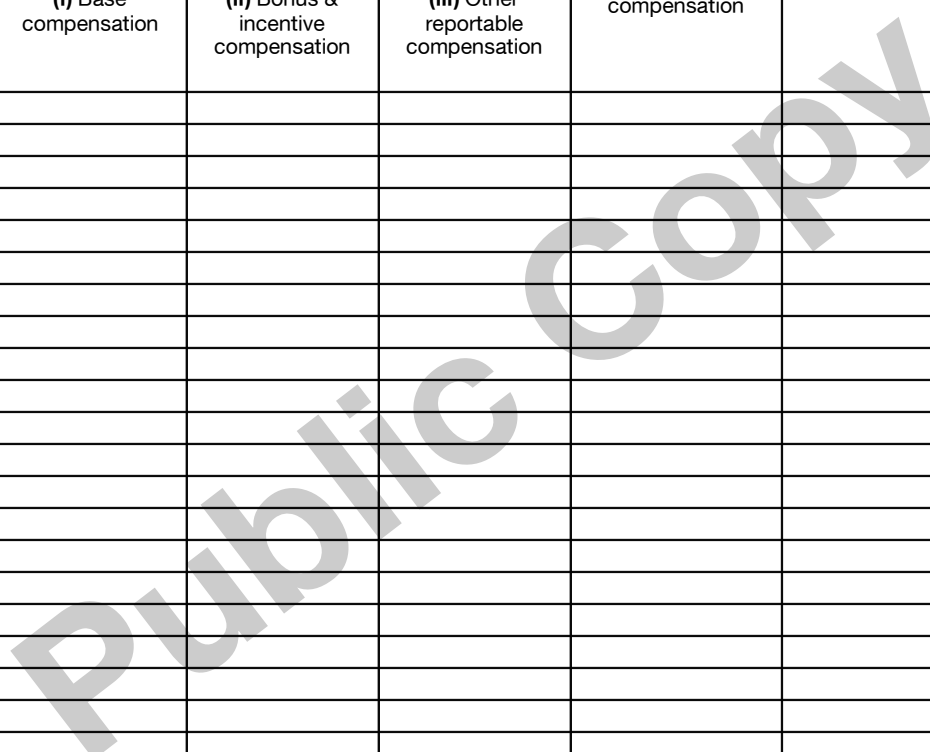

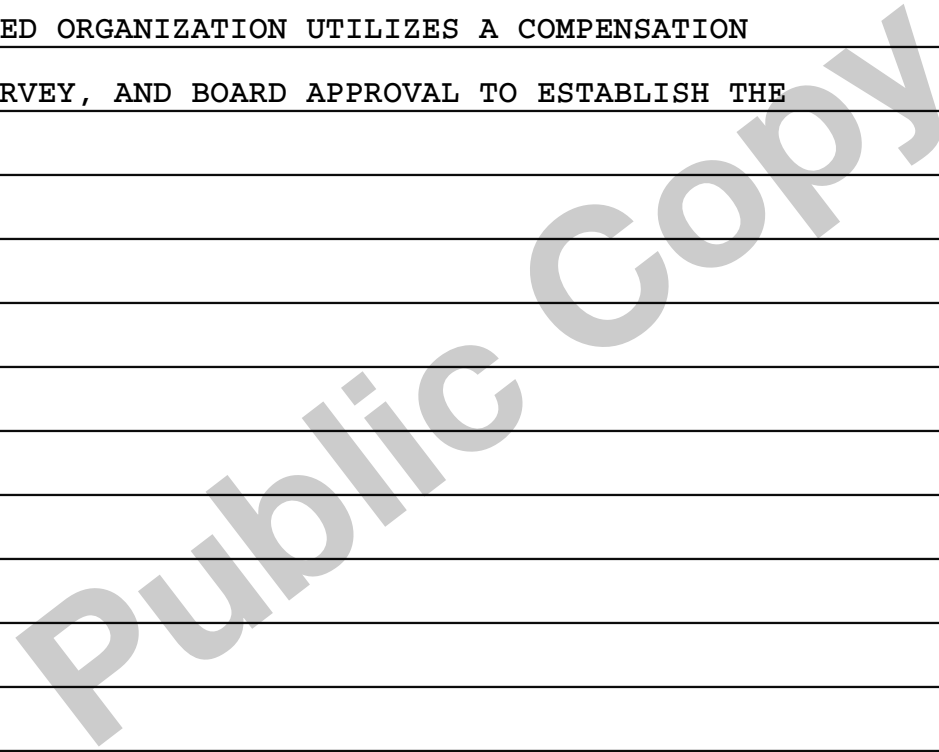



Plan of Merger

THIS PLAN OF MERGER (the "Plan of Merger") sets forth the terms and conditions for the merger (the "Merger") of Child Crisis Center Foundation, an Arizona nonprofit corporation ("Merging Corporation") and Child Crisis Arizona Foundation, an Arizona nonprofit corporation ("Surviving Corporation").

1. The Merger. On the Effective Date (defined below), the Merging Corporation will be merged with and into the Surviving Corporation in accordance with Arizona Revised Statutes §§ 10-11101 through 10-11106. The separate existence of the Merging Corporation will cease, and the Surviving Corporation will continue in existence as an Arizona nonprofit corporation and will succeed to all the rights, privileges, immunities and properties of the Merging Corporation and the Surviving Corporation will be responsible and liable for all the debts, liabilities and obligations of the Merging Corporation.
2. Effective Date. The Merger will be effective on the date that the Statement of Merger has been duly filed with the Arizona Corporation Commission (the "Effective Date").
3. Articles of Incorporation. The Articles of Incorporation of the Surviving Corporation, as in effect immediately prior to the Effective Date, shall be the Articles of Incorporation of the Surviving Corporation (the "Surviving Articles").
4. Bylaws. The Bylaws of the Surviving Corporation, as in effect immediately prior to the Effective Date, shall be the Bylaws of Surviving Corporation until thereafter amended in accordance with the Surviving Articles and applicable law.
5. Directors and Officers. From and after the Effective Date, until their respective successors are duly elected or appointed and qualified in accordance with applicable law, the individuals nominated by the Merging Corporation and the Surviving Corporation as set forth in the following sentence. Prior to the Effective Date: (a) the Merging Corporation will nominate three (3) candidates from its current board of directors to serve initial one-year, two-year and three-year terms, respectively; (b) the Surviving Corporation will nominate seven (7) candidates from its current board of directors to serve initial one-year, two-year and three-year terms, respectively; and (c) the President, President-elect, and designated Member At-Large from Child Crisis Arizona's board of directors shall serve until their respective successors are duly elected or appointed in accordance with Child Crisis Arizona's governing documents and applicable law.
6. Further Assurances. At any time, and from time to time after the Effective Date, each party will execute such additional instruments, provide such additional information and take such additional action as may be reasonably requested by the other party to carry out the intent and purposes of this Plan of Merger.
7. Amendment. This Plan of Merger may be amended, modified, superseded or canceled and any of the terms, covenants, representations, warranties or conditions hereof may be waived only by a written instrument executed by the parties.

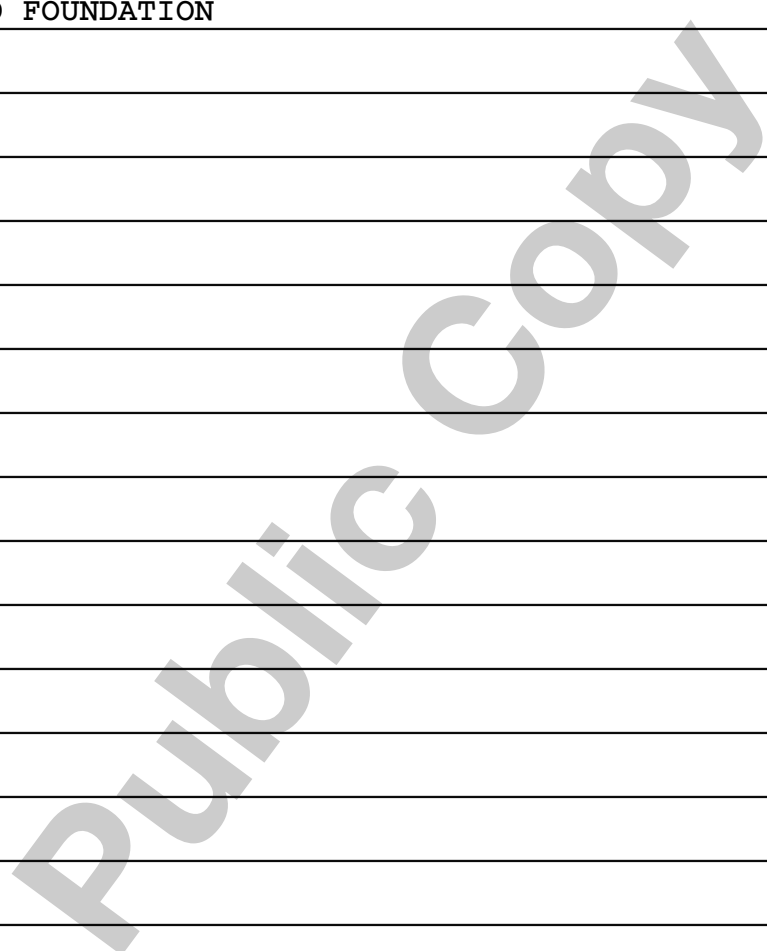

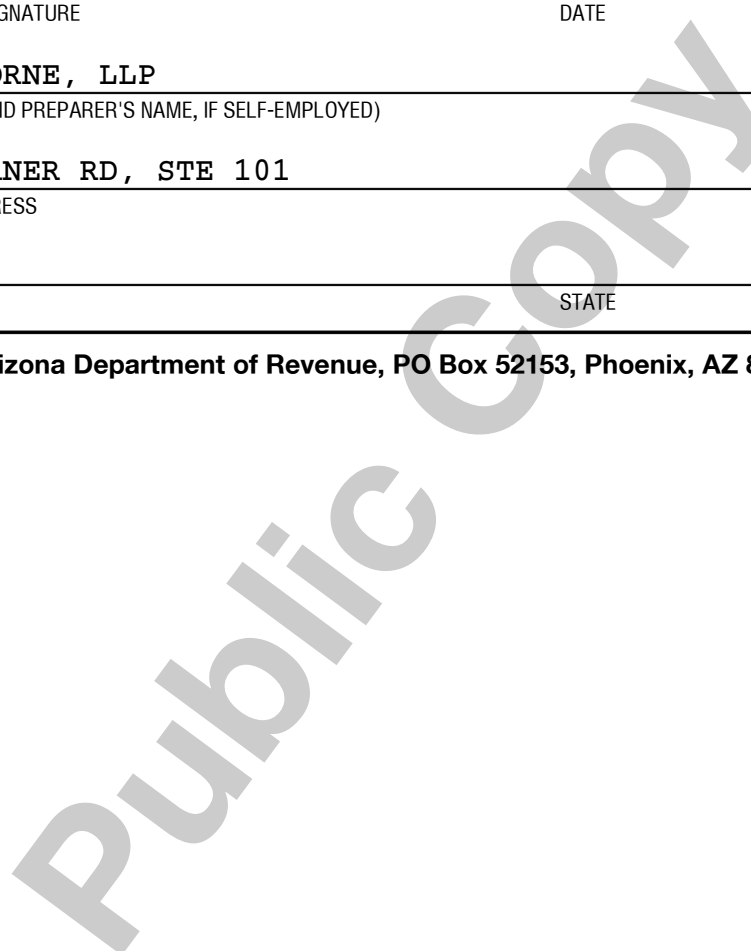
